- *Minimum 3 year experiences in monitoring and evaluation, project management, project development, organizational assessments, management consulting or related fields.*
- *Experience with Children's Education and Protection Project and project impacts.*
- *Excellent communication, writing, reporting skills in Khmer and English and the ability to communicate at all levels.*
- *Proven experience in extensive social research, policy and child analysis, community's livelihood and gender context.*
- *Advanced statistical analysis essential.*
- *English language fluency both writing and speaking, Khmer language skills an asset.*
- *Strong at facilitation, coordination and communication skills.*
- *A proven understanding and experience of child right, child protection and child education work with NGOs is strongly desirable.*
- *Experience in Cambodia or the region is desirable.*

Interested qualified candidates should submit a proposal containing the following elements:

- *Cover letter explaining the ways in which the evaluator(s) meet the required qualifications stated above.*
- *Curriculum Vitae of the evaluators.*
- *Technical proposal - including explanation and justification of the methods to be deployed;*
- *Financial proposal: Complete cost estimate that includes both the consulting fee as well as any ancillary costs to be incurred, such as transport, accommodation and taxes. SCC will cover the cost of the workshop with staff, which may be held in the SCC office.*
